

In pursuance of Chapter-IX of the Board's Regulations and Resolution No-14219/SME/ IX-SME (P)-35/13/Dtd-21/06/2013 of the Govt. of Odisha, Department of School & Mass Education, applications in the prescribed form are invited from High Schools of the state for accord of **Fresh/ Renewal/ Permanent Affiliation** for the academic session, **2016-17** as per the following guidelines.

1. The schools which have been issued No Objection Certificate by the Director, Secondary Education, Odisha with the clearance of the High Power Committee formed by the Govt. are eligible to apply for fresh affiliation.
2. The schools those have already been issued with Fresh/ Renewal of Affiliation and those have already been accorded recognition for Class-IX & X even once in the past (as per old pattern) are eligible to apply for Renewal of Affiliation.
3. The category of schools at supra '1' & 'i' above are also eligible to apply for Permanent Affiliation.
4. The schools which have not been accorded with Permanent Affiliation in previous years shall have to apply for Renewal of Affiliation/ Permanent Affiliation.
5. The government secondary schools are deemed to be affiliated to the B.S.E., Odisha and hence they should not apply for grant of affiliation.
6. **Fees for Affiliation:-**

Category	Fee
(a) Fresh Annual Affiliation	Rs.6000/-
(b) Renewal of Affiliation	Rs.4000/-
(c) Permanent Affiliation	Rs.15000/-


7. **Remittance of Fee:-**  
Fee shall be deposited by the intending schools in the **SBI Account No. 30995129371** through pay-in-slip of Board at various branches of the State Bank of India. Remittance of fee in any other manner shall not be entertained. They must attach the copy of the pay-in-slip with the application form.
8. (a) The schools at 1. & 2. supra are required to submit the photocopy of NOC/ Order of Fresh/ Renewal of Affiliation or last order of renewal of recognition as the case may be, with their respective application form.  
(b) The applicant schools shall submit the filled in application forms in duplicate along with all the enclosures, to the concerned District Education Officer on or before 05/04/2017. The District Education Officers shall send one copy of the application form along with their remarks to the concerned zonal offices on or before 12/04/2017. The Dy. Secretary, Zonal offices shall submit all applications received from the concerned District Education Officers at the Central Office, Cuttack on or before 28/04/2017.
