**TERMS AND CONDITIONS FOR CHECKING OF ADDITION OF MARKS AND FOR SUPPLY OF
PHOTOCOPIES OF VALUED ANSWER BOOKS TO THE DESIROUS CANDIDATES**

1. Candidates desire for checking of addition of marks and getting photo copy of evaluated answer scripts can apply in the prescribed format on or before 02.09.2025. Checking of Addition of Marks is a precondition for supply of photo copy of evaluated answer books.
2. A candidate desiring photocopies of valued answer books has to deposit an amount of Rs 300.00 (Rupees Three Hundred) only per paper towards Checking of Addition of Marks for subjective paper. The candidate desiring photocopies of the valued answer books has to deposit Rs. 200/- per OMR subject paper.
3. The candidate has to deposit Rs. 100/- (Rs One Hundred) only per paper towards checking of addition of marks per paper only i.e. without photocopies of answer books.
4. The results of checking of addition of marks shall be published in the Board website. The photocopy of the answer books shall be sent to the candidates by post in their address furnished in their application form. These dates shall be notified later in the leading Odia newspapers.
